

The following Havalendars of CGST & CX, Ranchi Zone, Patna are hereby promoted to the grade of Head Havaladar, (Group 'C' posts), in the Level-2 with pay matrix of Rs. 19,900-63,200/- (7th CPC pay) plus other allowances with effect from the date they assume the charge of the promoted post till further orders: -

2. Necessary compliance report regarding joining/non-joining in respect of officers promoted should be sent to this office by 17.04.2022 positively by the respective Commissionerates.
3. The Inter-se-seniority of the above promoted officers will be decided separately.
4. The promoted officers should exercise option for fixation of pay in terms of FR 22 1(a)(i) within one month from the date of joining as Head Havaladar and option once exercised will be final. However, the officers who have already been granted financial up-gradation under ACP/MACP Scheme are not entitled for any fixation benefit now.
5. The Order shall be subject to the outcome of any litigation pending on the issue of seniority/promotion and other related matter before any judicial forum.
6. The officers being promoted through this Order shall assume the charge of the post of the Head Havaladar in the same office where they are currently posted, till their posting in the promotional grade is decided.
7. The Controlling officer shall ensure that if any of the officers whose name figure in this Estt. Order is under suspension or facing any charge sheet or prosecution, he/she should not be allowed to assume charge of the post of Head Havaladar and this fact should be reported to this office immediately. Further, any of the officers figuring in this Estt. Order is undergoing any penalty; he/she should be allowed to assume charge of the post of Head Havaladar only after expiry of the currency of the penalty period. This fact also may be reported to this office.
