

2. Compliance report regarding joining/non-joining in respect of officers promoted should be sent to this office by 10.06.2022 positively by the respective Commissioner.
3. Inter-se seniority of the above-promoted officers will be decided separately.
4. The promoted officers should exercise option for fixation of pay in terms of FR 22 1(a)(i) within one month from the date of joining as Superintendent. Option once exercised will be final. However, officers who have already been granted financial up-gradation under ACP/MACP Scheme are not entitled for any fixation benefit now.
5. This order shall be subject to the outcome of any litigation pending on the issue of seniority/promotion and other related matter before any judicial forum.
6. Officer being promoted in this order shall assume the charge of the post of the Superintendent in the same office where he is currently posted at this stage. The officers getting promotion during posting in Customs Patna, will be repatriated to Cadre Controlling Authority i.e. CGST& CX., Patna immediately as per Zonal Transfer Policy, 2020.
7. Commissioner shall ensure that if the officer whose name figures in this Estt. Order is under suspension or facing any charge sheet or prosecution, he/she should not be allowed to assume charge of the post of Superintendent. Further, in case any officer is undergoing a penalty, he/she should be allowed to assume charge of the post of Superintendent only after expiry of the currency of the penalty period. Such facts be reported to this office.
