
The said transfer will be effective from date of joining of duty and upon acceptance to abide by all terms and conditions, as laid down in above said Board's letter dated 27.10.2011:-

1. The transferee will be placed below all officers appointed regularly to that post/grade on the date of his/her appointment on transfer basis in terms of Para 3.5 of DOP & T's O.M. dated 03.07.1986. In other words, such a transferee will be junior to those regularly appointed officers prior to his transfer. However, such transferred officer will retain his eligibility of the parent Commissionerate for his/her promotion to the next higher grade, etc.

2. On transfer he/she will not be considered for promotion in the old Commissionerate.
3. He/she will not be entitled to any joining Time and Transfer Travelling Allowance.
4. That, they are liable to be transferred anywhere within the jurisdiction of CGST & CX, Ranchi Zone, Patna and Customs (P) Commissionerate, Patna.
5. Before the above officers are relieved, Vigilance Clearance & Integrity Certificate(as on date), Bio-data as per Service Book of the individual (duly attested by the concerned DDO, attested copy of "History of Posting" updated ACRs/APARs & IPRs may be sent to this Zone. If for any reason, there is a vigilance case pending/contemplated against the concerned officer, then prior to his relieving, details must be sent to this Zone.
6. The officer should report to the undersigned immediately after getting relieved from his/her parent Commissionerate, but in no case later than 15.12.2021 failing which, the order will be deemed to have been cancelled, ab-initio, with reference to such officer, without any further intimation to him or her.

The Inter-se seniority of these officers in CGST & CX, Ranchi Zone will be decided separately as per extant rules.

This issues with the approval of the Chief Commissioner, CGST & CX, Ranchi Zone, Patna.




